1. Acknowledgment and Assumption of Risk

2. Release of Liability

3. Media Release

The Participant (and, if under 18, their parent or legal guardian) grants permission to the Activity Provider and its agents to capture and use photographs, video recordings, and audio recordings of the Participant taken during the event. These materials may be used, without compensation, in promotional materials, publications, websites, press, or social media to promote the event or the organization. The Participant waives any right to inspect or approve the final media or its usage.

4. Fitness to Participate

The Participant affirms that they are in good physical and mental health and are not aware of any medical conditions that would prevent them from safely participating in the event. If such a condition exists, the Participant agrees to consult a physician and obtain medical clearance prior to participation.

5. Code of Conduct

The Participant agrees to follow all instructions provided by the Activity Provider and event staff. Disruptive or unsafe behavior may result in removal from the event at the sole discretion of the Activity Provider.

6. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of Texas.
